Read it carefully before signing.  <b>I AGREE</b> in consideration for my participation in the Competition to the following:  <b>I AGREE</b> that the "Competition" as used above includes the Ludwig's Corner Horse Show, the Ludwig's Corner Horse Show Association/Foundation, all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.  <b>I AGREE</b> that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").  <b>I AGREE</b> to hold harmless and release the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Competition.  <b>I AGREE</b> to expressly assume all risks of Harm to me or my horse, including Harm results from the negligence of the Competition.  <b>I AGREE</b> to indemnify (that is, to pay any losses, damages, or costs incurred by) the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claim made by others for any Harm caused by me or my horse while at the Competition.  I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Competition strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
